### **Presentación del curso**

¿Por qué parece estar en crisis la democracia en el mundo? ¿Cuáles son los problemas que la aquejan y qué explica su buen o mal funcionamiento, su quiebre o supervivencia? Este curso ofrece una visión comparada de la historia y el estado de la democracia moderna, así como de las dinámicas de la autocratización en el contexto contemporáneo. Para adentrarse en estas preguntas, primero se revisan, desde la política comparada y la teoría política, distintas concepciones de la democracia y de los regímenes que le son antagónicos. Examinamos las ventajas y desventajas de diferentes formas de conceptualizarla y medirla. Después, el curso revisa experiencias históricas decisivas de democratización y quiebre democrático, con miras a los desafíos del presente. La tercera parte del curso revisa las recesiones democráticas actuales. Entre los temas a cubrir se encuentran los problemas de representación, las tensiones entre la soberanía popular y los componentes liberales de la democracia y las nuevas-viejas formas de erosión y ruptura. A lo largo del curso se pone atención a la trayectoria democrática de México, desde la transición hasta el momento actual, pero siempre en diálogo con la literatura comparada y la experiencia global.

### **Políticas generales y logística del curso**

- Las sesiones de clase seguirán un formato de seminario/mesa redonda, con énfasis en la presentación de los estudiantes y la discusión crítica de los temas y lecturas del día. La lectura atenta y reflexión previa a las sesiones son obligatorias e indispensables. También lo son la participación activa y la disposición para la discusión racional y respetuosa durante las sesiones.
- La asistencia a clase es obligatoria. El estudiante puede perder su derecho a recibir una calificación por inasistencias y/o por acudir a la clase sin haber cubierto el material asignado. En caso de no poder asistir a la clase por causa justificada, favor de comunicarse con el profesor.
- La participación en clase será un componente sustantivo de la calificación final y será evaluada en función de la regularidad, oportunidad y calidad de las intervenciones.
- El uso de celulares o chats durante la clase está estrictamente prohibido.
- Salvo por causas extraordinarias, las entregas tardías serán penalizadas con 2 puntos por día. Tratándose de los memorandos para discusión, la penalización será de 1 punto por cada hora de retraso.

## **Memorandos y presentaciones**

- Dos veces en el semestre, cada estudiante escribirá una reseña crítica (800-1,000 palabras) y hará una breve presentación (5-7 minutos) sobre el tema y lecturas asignados. Estos memorandos y presentaciones no deben ser un resumen de las lecturas, sino hacer una evaluación crítica sobre las fortalezas y debilidades de las lecturas, contrastar distintos argumentos o aproximaciones al tema en cuestión y abrir un conjunto de preguntas para ser discutidas en la sesión de clase. La reseña crítica deberá circularse electrónicamente a los integrantes del curso a más tardar 24 horas antes de la sesión respectiva.

## **Trabajo final (entrega 6 de diciembre):**

- El trabajo final tratará una pregunta elegida libremente por el estudiante dentro de la temática general del curso. La pregunta o *puzzle* deberá estar planteada en forma explícita al inicio del trabajo y requerir lectura e investigación independiente por parte del estudiante. Los estudiantes podrán consultar con el profesor acerca de su pregunta de investigación a lo largo del semestre. La extensión del trabajo será de entre 12 y 15 páginas.
